January 2010

The Parachute Branch relocated to a temporary facility in downtown Parachute. Seventy-five percent of the subcontractors who worked on the Parachute and Rifle Branch

In 2010, we opened two new libraries, Rifle and Parachute. The past year was an exciting one for the District as we opened two beautiful new libraries. The feedback we've received from users has been exceptionally positive and we are thrilled that both buildings have seen a significant increase in use and have attracted droves of new library card holders. Both facilities received financial support from individuals, businesses and governmental agencies. In particular, donations from Encana Energy and grants from the Governor's Energy Office and the Colorado Department of Local Affairs helped us to achieve our goal of creating energy-efficient, cost-effective buildings that reduce our overhead and expenses.

We also worked toward improved services for our patrons by adding self-checkout stations to all branches in 2010. Despite the continued decline in sales tax revenues, we were able to purchase a large variety of new materials and worked with our online catalog provider (Marmot) to develop a new, user-friendly interface called VuFind that enhances your ability to find and place holds on items. As we look ahead, the District will continue to seek practical and innovative solutions to your library needs.



Analysis of the Two Funding Sources

Quarter Cent Sales Tax



The designated quarter cent sales tax pays to keep your libraries open. Sales tax revenues decreased \$500,000 from 2009, for a total decrease of over \$1.4 million in 2 years.
